# **SEC-05-DRS-2016-2017: Chemical, biological, radiological and nuclear (CBRN) cluster Part (b)**

## **Specific Challenge:**

**Technologies and innovations in the field of CBRN are developed by SMEs or larger companies which often face difficulties in bringing them to markets:** because they address local, small niche markets; or because these SMEs have neither the capabilities nor the strategic objective to go for foreign markets; or because the individual technologies that they develop can make it to the market only if integrated and combined with other tools by other companies that have the capabilities and the strategy to market its products abroad, and possibly on the global market.

Such synergies among companies are not frequent in the area of CBRN technologies, which is to the detriment of **industrial competitiveness**, and which limits considerably **the offer made to the practitioners** if one compares with the actual technological state-of-the-art.

# SEC-05-DRS-2016-2017: Chemical, biological, radiological and nuclear (CBRN) cluster Part (b)

## Scope

- **Part b) (2017): Several RIA aiming at research and development of novel CBRN technologies and innovations identified in the above-mentioned catalogue will be selected by the European Commission.** Each of these actions will be led by an SME. Each consortium implementing such a RIA must not only establish a consortium agreement among its members, but also a collaboration agreement with the participants in the CSA supported through Part a). Such a collaboration agreement must settle how the results from the RIA will be exploited and integrated into platforms managed by the CSA.
- The outcome of the proposal is expected to lead to development up to Technology Readiness Level (TRL) 4 to 7 for the RIA under part b); please see part G of the General Annexes.

# SEC-05-DRS-2016-2017: Chemical, biological, radiological and nuclear (CBRN) cluster Part (b)

- **Expected Impact:**
  - Shorter time to market for novel CBRN technologies and innovations
  - More business deals among CBRN industrial players
  - More industrial products of interest to more practitioners in Europe (and world-wide)
- **Budget:**
  - EU req contribution ~ 3,5 M€/project. 13,75 M€ total budget (4/5 proyectos)

# Relación Scope parte (a) y parte (b)

- (...) *The participants in the CSA will provide platforms (toolkits and systems in the field of CBRN) in which to integrate the technologies and innovations developed by other companies under Part b)*
- (...) ***The CSA will deliver the first version of the catalogue*** on time for use in the implementation of Part b).
- (...) *The participants in the CSA will provide commercial and other services enabling access to the global market for the results of the RIA selected for support under Part b).*
- (...) *The CSA will report publicly on its discussions, and assess and provide feedback on the impact of the business deals implemented with the research and innovation activities led by SMEs under Part b) of this topic.*

# Condiciones de elegibilidad

- **For part b) (2017):** each RIA must establish its « normal » consortium agreement, as well as a "**Collaboration Agreement with participant(s) in the CSA**". A draft of the "Collaboration Agreement" must be attached to the RIA proposal, and endorsed by at least one participant in the CSA.
- All beneficiaries of the RIA grant agreements **must be independent** from each beneficiary in the CSA.
- **Each RIA proposals must be coordinated by an SME.**
- For grants awarded under this topic **SEC-05-DRS-2017 part b)** option 1 of Article 41.3 of the [Model Grant Agreement](#) will be applied.







# ENCIRCLE TRANSITION PERIOD BEFORE END MARCH 2017

## SEC-05-DRS Part b (2017) Call for proposals



- **ENCIRCLE kick off on March 21-22 2017, after the 2017 call is issued**
- ENCIRCLE will propose a list of priority topics for the 2017 Part B call, **by end of March 2017**  
for the EC to accommodate if possible the priorities complementary to the call to focus the proposals (TBC by the EC)
- The 2017 priority topics will be selected according to the **ENCIRCLE arbitration process**, based on the state of the art knowledge, needs and gaps, technical feasibility and market opportunities
  - From EDEN (needs and gaps, tools catalogue, final workshop)
  - Other relevant projects
  - **Informal Consultation of the CBRN community (technical and industrial primarily), (deadline mid March)**

# ENCIRCLE PROJECT OPERATIONAL (after June 2017)

- Access, registration and catalogue population will then be via the **ENCIRCLE** portal
  - after agreement with the ENCIRCLE consortium
- Static Tool catalogue will then be replaced by the **ENCIRCLE Dynamic Catalogue**
  - Initial instance expected in April 2017
  - Complete instance expected June 2017
  - Supported by **networks and associated services**
- Consolidated Recommended Priority topics for the 2017 call will be made available end of March
  - on **ENCIRCLE** website
  - and via DG HOME



## SEC-05-DRS 2017 Part b proposal preparation: interfaces with ENCIRCLE

- ENCIRCLE will not interfere in the evaluation/selection of the proposals.
- **Prepare your proposal « as usual »:** in line with all the aspects of the call (SME lead, response to the priority topics, etc)
- If your proposal is selected, the **article 41.3 of the Model Grant Agreement will apply**. It requires confidential exchanges of results.  
Ensure in your proposal that you agree to exchange information and results with the ENCIRCLE consortium in order to monitor the progress achieved and the future integration and exploitation opportunities, in line with Article 41.3 option 1 of the Model Grant Agreement.
- Specific agreements with the ENCIRCLE consortium can be described in the consortium agreement, if needed. In any case, **the IP will remain within the participant that produces it** and decides of its exploitation.
- Partners of the selected proposals may wish during the course of the project to set **specific agreements** with integrators or other suppliers for further exploitation.


